**The 2021 Energy Code:
How to Achieve Code Compliance**

Implementation of the new International Energy Conservation Code (2021 IECC) represents about a 9% energy savings and carbon emissions reduction over the previous 2018 Code. The new code includes increased requirements for thermal resistance and for airtightness. This session will explore building envelope changes in the 2021 IECC. We will cover the three paths of compliance: prescriptive, performance, and the Energy Rating Index, and review mandatory items for all the paths. We'll focus on what insulators need to know to achieve code compliance using a range of insulations and discuss the increasing prominence of continuous insulation.



We'll be playing on the Devil's Claw Course, a masterpiece developed by Gary Panks that will impress and challenge golfers of all levels, while maintaining a sense of fairness and playability. Featuring pristine and uncluttered views of the Sierra Estrella Mountains, the course shares acres of turfed area with the desert landscape and showcases the beauty of the natural terrain.

The Devil's Claw Course was created to reflect the land while the waters still flowed on the reservation by combining the Gila River landscape including Cottonwood, Mesquite, Saguaro and Palo Verde trees, with native grasses and rolling terrain. This challenging golf course also features gradual elevation changes, great bunker designs, and multi-tiered greens.
